Sub: Regarding preparing a list of Peer Reviewed Journals for the purpose of Promotions in University Departments/Direct Appointments

Dear Sir,

As you are aware, the University of Delhi has amended the norms of screening criteria with regard to consideration of research papers for direct recruitments on the post of Assistant Professor/Associate Professor/Professor, vide EC resolution no-16 dated 09.06.2023, and for promotions of teachers in University Departments vide EC resolution no. 39-8 dated 15-12-23 (ref: University Notification nos.Ref. No. R&P/017/2024/027 and Ref. No. R&P/017/2024/028 dated 03.06.2024, attached). In these amendments, the University has asked the Departments to draw a list of the journals which are of good quality, however, not indexed in SCI/SSCI/SCOPUS indexed/UGC CARE listed Journals. The papers published in these journals, once recommended by the respective departments and approved by the University will also be considered for appointment/ promotions in University Departments.

Therefore, DUTA demands that each department prepare a list of quality Journals which are not indexed SCI/SSCI/SCOPUS indexed/UGC CARE listed Journals in consultation of DRC and then recommend and submit to the University for favourable consideration.
